### MINUTES

#### PARISH COUNCIL MEETING

1. **To receive any declarations of interest**- None

2. **To receive any apologies**- Mrs K Raine (ill)

3. **To discuss footway lighting in Kirkoswald Parish**

Mrs P Bowman briefed the meeting about the process and reasons for the changes to the footway lights in the area. Mr J Little said that he felt the decisions should be an open parish meeting, rather than by the Parish Council alone. Mrs I Henderson suggested and it was resolved to consider each lamp at this meeting and then hold a public meeting to discuss results.

#### **Lights in Renwick**

- Opposite 2 Lea Croft, CA10 1JT (R1)- Councillors believe that this light meets all conditions
- Opposite The Rookeries, CA10 1JL (R5)- Councillors believe that this light meets all conditions as it links the community to amenities as it is close to the church.
- Outside 2 The Hill, CA10 1JL (R6)- Councillors believe that this light meets all conditions as it lights two footways, links to main street and church, chapel and reading room. It lights a dark, cobbled, steep hill.
- Opposite North View, CA10 1JL (R7)- Councillors believe that this light meets all conditions as it is at the entrance to farm, links to a public footpath and there are no other lights in the vicinity.
- Opposite School House, CA10 1JL (R8)- Councillors believe that this light meets all conditions as it links Spa Lane to the church, chapel, reading room and remaining community.
- Outside Spa Cottage, CA10 1JL (R9)- Councillors believe that this light meets all conditions as there are five properties with no lighting in the other direction.
- Outside Reading Room, CA10 1JT (R10)- Councillors believe that this light meets all conditions as it is outside a public amenity.

### **Light in Staffield**

- Councillors believe that this light meets all conditions as it is the only light in hamlet and is a necessity.

### **Lights in Kirkoswald**

- Outside The College, CA10 1DQ (K1) ) Councillors agreed that lights K1 and K2 could be removed
- Opposite Desmene, CA10 1DQ (K2) ) and replaced with another light between the two
- Outside Laces Garage, CA10 1DQ (K3)- Councillors believe that this light meets all conditions as it is on parish land which is used as a car park.
- Opposite Incy Bella, Raven Bank, CA10 1DQ (K7)- Councillors believe that this light meets all conditions as is on a footway which leads to the playing field, church and shop.
- Outside Lane House, CA10 1EE (K10)- Councillors believe that this light meets all conditions as it is the only light on the back lane.
- Opposite 1 Town End Cottage, CA10 (K17)- Councillors believe that this light meets all conditions as it is on a footway that leads to the chapel, gardens and everything in the centre of the village.
- Outside Netherlea, CA10 1EN (K21)- Councillors believe that this light meets all conditions as it lights a footway on the opposite side of the road.
- Outside Fayrefield, CA10 1EZ (K22)- Councillors agreed that this light could be lost.
- Opposite 2 Council Houses, CA10 1EY (K23)- Councillors believe that this light meets all conditions as it lights a public footway and links the community with amenities.
- Outside Lawson Cottage, CA10 1EY (K24)- Councillors believe that this light meets all conditions as it lights a public footway and links the community with amenities.
- Outside 5 Croft Place, CA10 1DL (K25)- Councillors questioned the ownership of this light (is it owned by Eden Housing Association).
- Outside Berrymoor Cottage, CA10 1EZ (K26)- Councillors agreed that this light could be lost.
- Outside 8 Croft Place, CA10 1DL (K27)- Councillors questioned the ownership of this light.
- At the entrance of Croft Place, CA10 1DL (K28)- Councillors questioned the ownership of this light.

It was resolved that councillors speak to those households likely to be most effected by the removal of lights prior to the meeting on Tuesday 12<sup>th</sup> March, 2013.

4. **Date of the next meeting**- Councillors agreed to hold an open public meeting at 7pm on Tuesday 12<sup>th</sup> March, 2013, followed by the ordinary monthly meeting at 7.30pm. Parishioners are welcome to come along to the open meeting at 7pm to express their opinions on lighting. The meeting will be held in Kirkoswald Church Institute.
